LAPD

- Officer Sanchez handed out an LAPD of the Hollywoodland district. The map used for crime statistics excluded Rodgerton Dr., which is in a separate district.
- The New Year's Eve Hollywood Sign vandal turned himself in and the City Attorney is working on charges of "trespass in a high fire area". The vandalism was not caught on camera that is monitored by a third party security officer.
- CD4 and LAPD want to pay more attention to the hiker/tourist problem and are putting a plan together for Spring Break and all other holidays. Sanchez stated that they "know that there are issues". Rules are being sought for Uber and Lyft, as well as changing the laws for tour buses. There will be more LAPD motor units, parking enforcement and Park Rangers.
- The protection of the Mt Lee communications site is a concern to the LAPD and they want to add more security and personnel. According to the officers it is "one of the biggest infrastructures in the city". However, protection of the facility is secondary to protecting the Hollywood Sign. Officer Sanchez stated that an "attack on the sign would be an attack on western civilization." Currently there is one security service officer and one-third party service officer monitoring forty cameras on the sign.
- LAPD is aware of the increased tagging in Hollywoodland.

RODGERTON PARTY HOUSE

- Several Rodgerton and Ledgeewood residents discussed how the neighborhoods have become hell with a after-hours party club has taken up residence on Rodgerton Dr. The invites to the club are through social media.
- The owner has been contacted to no avail.
- Sometimes the home is used as a recording studio.
- LAPD will try and contact the owner and will get their vice unit involved for an investigation.
